

# Cookies Policy “Extended Information Notice”

Information notice in compliance with the obligations laid down by Article 10 of Directive no. 95/46/EC, Directive 2002/58/CE, as updated by Directive 2009/136/CE, article 13 of (It.) Legislative Decree of 30 June 2003, no. 196, and by the general decree (web document no. 3118884) of the Personal Data Protection Authority, published in Government Gazette no. 126 of 3 June 2014, register of measures no. 229 of 8 May 2014 on Cookies on “[Simplified arrangements to provide information and obtain consent regarding cookies](#)”.

## Premise

The site uses cookies to facilitate the provision of its services, to obtain anonymous and aggregated statistics, as described in greater detail below. The User may refuse to grant consent to the use of cookies by taking measures on his/her own browser or by disabling the specific service. Disabling the site's cookies could influence navigation inside the website and compromise the operation of our services. When the User accesses any page of the site, he/she will be presented with an “Information” banner; by closing it, by clicking on the “Accept” button or in any other way, the User grants consent for the use of cookies in conformity to this Cookies Policy. We suggest, therefore, that you take some time to read this information notice. This document, together with the “Privacy Policy”, is accessible at any time via the related link posted in the footer of each page of the website.

## What are cookies?

A cookie is a small text file that is installed on the user's computer, on his/her smartphone or on other devices, when he/she visits an Internet site. Cookies help Internet sites to recognise devices when they next visit. There are other similar technologies, such as pixel tags, web bugs, web storage and other similar files and technologies that operate in the same way as cookies. In this document, the term “cookies” is used to describe all technologies that collect information in this way. The majority of websites uses cookies, because they are one of the tools that can improve the navigation experience of users. Cookies allow websites to offer personalised services (for example, remember an access, store products in the shopping cart or display important content).

## Types of cookies used

**Session cookies:** These cookies are essential as they allow the user to navigate the site and to use its services. They do not collect information that may be used for marketing purposes or to track Internet browsing. These cookies are related to each session and expire once the user's visit (session) of the website is finished. They cannot be disabled.

**Functional cookies:** These cookies allow the site to remember your choices (such as Username and Password) and make available optimised and more personal functionalities. The information collected by these cookies may be provided anonymously and they are not capable of tracking the user's browsing activities on other websites. They cannot be disabled.

**Analytics cookies:** These cookies are installed by ShinyStat™ and are used to collect information on the ways in which the users use the site, such as the number of visitors, the websites from which they access the site (referrer) and the pages consulted. We use this information to compile statistical reports and so that we may improve our services.

## ShinyStat™

ShinyStat is a statistics service provided by Shiny S.r.l., the cookies of which are similar to technical cookies, in the sense that they are used to collect aggregated and anonymous information on the number of users and on how they navigate the websites.
